- (A) Waive and release any and all claims that I may have against Northview Bible Church (NBC) their officers, directors, members, volunteer persons, employees, and agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors, or assigns (the Releasees), including any and all claims for damage caused by the negligence of any of them, arising out of my participation and their related activities, together with any costs, including attorneys' fees that may be incurred as a result of any such claim whether valid or not, and
- (B) Indemnify and hold harmless the Releasees and each of them against any such claim that I or my guests or any one or more of them or my or their executors, administrators, heirs, next of kin, successors, or assigns may have or assert and against any cost including attorneys' fees and respect thereto.
- (C) Assume all the forgoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- (D) Release, waive, discharge and covenant not to sue Northview Bible Church (NBC) or any affiliated groups, their respective administrators, directors, agents, pastors, and other employees of the organization, other participants, sponsoring agencies, sponsors, volunteers, and if applicable, owners and renters of premises used to conduct the event, all of which are hereinafter referred to as "releasees," from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
